INSPECTION AND COPYING OF MARRIAGE OR CIVIL UNION LICENSE APPLICATION

Pursuant to C.R.S 24-72-204(3)(a)(XIX)(A) County Clerks and Recorders as the custodian of applications for a marriage and Civil Union Licenses, are prohibited from permitting inspection of such applications, except by a court order, original applicants, or member of the immediate family to either party to the application.

Inspection of marriage licenses and marriage certificates is still permitted and not affected by this statute.
